All amounts herein are expressed in USD. This Order shall control in the event of any conflict between this Order and the Agreement.

- <u>Effective date:</u> The date of execution of this Order.
- Subscription Term: 20 months as of July 31, 2025 up until March 31, 2027.
- <u>Term</u>: As of the Effective Date and until the end of the Subscription Term set forth in this Order.
- Renewal Option: Customer shall have the right to extend the Subscription Term for an additional period of four (4) months (the "Renewal Option"), subject to providing Moovit with written notice no later than thirty (30) days prior to the expiration of the current Subscription Term. In such event, Customer shall pay Moovit a total amount of \$86,666 comprised of (a) \$83,333 for the Mobile App Subscription and (b) \$3,333 for Subscription and Support services in connection with the Elerts integration.
- Payment Terms: Invoices shall be paid Net + 30, and shall be issued as following:
 - For the Renewal Fee: 1 invoice, for the amount of US \$ 433,334 shall be issued upon the Effective Date.
 - For *Optional* additions: invoice shall be issued upon Customer request to add the applicable feature.
 - In the event that the Customer elects to exercise his Renewal Option, Moovit shall issue an invoice in the amount of USD \$86,666 upon Customer's renewal notice.
