In response to a question from Commissioner Daniels, Lona Hankins reported that the RTA was \$300,000 short on State Operations Funds for the Chalmette Ferry and \$6.9 short on the Algiers Ferry. Senator Carter was able to get the RTA \$150,000 for Chalmette Ferry and currently conversations were taking place with the City of New Orleans and the New Orleans City Council regarding funding for the Algiers Ferry. Senator Cater did create a team to study how a permit funding stream could be developed for both of the vessels.

Commissioner Daniels asked that staff create a report showing the scenarios on what may happen if the RTA does not receive the necessary funding for the vessels and what would be RTA's options.

Commissioner Daniels also asked if there was an industry standard regarding maintenance on the buses, streetcars and ferries.
