## AUTHORIZATION TO EXECUTE A ONE-YEAR EXTENSION TO ADS SYSTEM SAFETY CONSULTING, LLC FOR CONTINUED ON-CALL TECHNICAL SAFETY SUPPORT SERVICES

**WHEREAS**, the Regional Transit Authority (RTA) executed contract #2021-016 with ADS System Safety Consulting, LLC ["ADS"] for on-call, technical safety support services in November 2021 and seeks an extension of services; and

**WHEREAS**, the RTA Board of Commissioners authorized the Chief Executive Officer to extend an existing contract with ADS (#21-154); and

**WHEREAS**, the initial contract term was three (3) years and the contract included two (2) one-year options to renew; and

WHEREAS, the current contract expires on or about November 5, 2024; and

**WHEREAS**, the technical safety support services provided to RTA under this contract assist with RTA's compliance with federal and state requirements related to transit system safety including, but not limited to, those codified in Title 49 of the Code of Federal Regulations ["CFR"] Parts 670, 672, 673, and 674, and with RTA's ongoing efforts to ensure the safety of employees, customers, and the general public; and

**WHEREAS**, RTA requires technical services for ongoing safety and regulatory work including system safety audits, corrective action development, and accident and incident investigations, as well as for ad hoc technical safety tasks upon request by RTA Executive Leadership; and

**WHEREAS**, RTA staff have determined that the extension of services will cost approximately ONE HUNDRED FIFTY-THREE THOUSAND, SEVEN HUNDRED TWENTY-ONE DOLLARS AND SIXTY-SIX CENTS (\$153,721.66); and

**WHEREAS**, funding is available through RTA Operating Account #1-4600-02-7070-166 for a total cost **NOT TO EXCEED** ONE HUNDRED FIFTY-THREE THOUSAND, SEVEN HUNDRED TWENTY-ONE DOLLARS AND SIXTY-SIX CENTS (\$153,721.66);

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the Regional Transit Authority (RTA) that the Chairman of the Board, or his designee, is authorized to execute an extension of contract #2021-016 for the continued, on-call technical support services of ADS System Safety Consulting, LLC.
