**AUTHORIZATION TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT BETWEEN  
CITY OF NEW ORLEANS AND REGIONAL TRANSIT AUTHORITY**

**WHEREAS**, The RTA intends to renovate the Algiers Ferry Terminal on Morgan Street in the Algiers Point Neighborhood; and

**WHEREAS**, In 2019, the City of New Orleans secured \$291,000 in funding from the State of Louisiana ("State Funding") to cover construction costs related to the renovation of the Algiers Ferry Terminal; and

**WHEREAS**, pursuant to Article 7, Section 14(C) of the Louisiana Constitution of 1974, and related statutes, and Section 9-314 of the Home Rule Charter of the City of New Orleans, the City may enter into a cooperative endeavors with the State of Louisiana and its political subdivisions and corporations for, among other public purposes, joint planning and implementation of public works; and

**WHEREAS**, The City of New Orleans and RTA staff have mutually agreed on the terms of a Cooperative Endeavor Agreement that will allow the State Funding to flow from the City to the RTA to support the renovation of the Algiers Ferry Terminal; and

**WHEREAS**, The State Funding constitutes an important source of capital dollars that will facilitate the renovation of the Algiers Ferry Terminal starting in 2025; and

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the Regional Transit Authority (RTA) that the Chairman of the Board or his designee execute a Cooperative Endeavor Agreement with the City of New Orleans to obtain State Funding for the renovation of the Algiers Ferry Terminal.
