**Authorization to amend the contract between Mythics, Inc. and the  
Regional Transit Authority**

Introduced by Commissioner Ewell, seconded by Commissioner  
Neal.

**WHEREAS**, Oracle Cloud ERP purchase and implementation agreed upon by the RTA Board of Commissioners in May 2022; and

**WHEREAS**, implementation of Oracle software for all modules began August 2022; and

**WHEREAS**, the RTA Board of Commissioners approved the upgrade of software to Oracle Cloud Services applications as critical to maintaining levels of service for RTA's personnel and services; and

**WHEREAS**, large scale fare modernization initiatives, department specific projects, staff attrition, and individual duties limited the contractor/RTA availability and interactions; and

**WHEREAS**, Mythics has been working with the RTA Finance, Purchasing, Maintenance and HR teams since August 2022, and has become familiar with the Oracle processes and industry best practices which are possible to implement within Oracle Fusion Cloud; and

**WHEREAS**, Mythics configured Oracle Fusion Cloud and held deep dive sessions in each module to allow RTA to evaluate the system in greater detail which resulted in RTA requested changes in scope, timeline and the estimate level of effort to accomplish the targeted March 31, 2023, go-live; and

**WHEREAS**, changes to scope entail module revision, data conversion between JDE and Oracle as well as the added costs to integrate across other department specific software programs; and

**WHEREAS**, staff conducted a thorough evaluation of implementation requirements, options and potential vendors to determine a preferred solution and determined integrations to existing software for maintenance and human resources functions was more cost effective and better suited to RTA business practices; and

**WHEREAS**, staff determined costs associated with integration of key software with Oracle platforms are the responsibility of the Oracle implementation project;
