2025-R013	06/04/25	6/12/2025	The agency received an email supporting the pilot program to extend ferry hours, but it recommended an earlier start time since most employees in the hospitality industry must report for work before 6:00 am. Additionally, the email advised against implementing the pilot during the summer slowdown, as this could provide an erroneous impression of the impact.	Operations/Ferry/Communications	The ferry pilot will occur from June 15- September 27 2025. The slow season is by design to ensure that the revenue generated will cover expenses during the slowest possible period to mitagate any financial risk to the agency.
2025-R014	06/04/25		A RAC speaker complained about the printed schedules being inaccurate and inquired what percentage of riders are using them.	Communications/Planning	
2025-R015	06/4/2025 6/30/25	07/07/25	Staff were asked to look into an ongoing traffic hazard in the 2100 block of France Street by two RAC speakers. The speakers mentioned that they had previously appeared before RAC with this issue and had seen improvements with speeding buses. The Board received two additional emails regarding the same issues of speeding and structural damage to the road and nearby properties being caused by the #84 Galvez bus route. The most recent communication also complained about a bus side swiping a parked SUV.	Operations/Planning Operations/Planning/Safety	RTA is coordinating with the City of New Orleans Department of Public Works (DPW) to evaluate the intersection of Poland and Galvez for a traffic control device (e.g. traffic signal) - this improvement is necessary for RTA buses to safely turn to/from Galvez directly on Poland and not use France St. DPW is working to engage their on-call traffic consultant to start the analysis. The team pull a report from the vehicle from 07/02/05. The operator as he is approaching N. Galvez and France was operating at 11 mph. Once he turned onto France Street, he is operating at 3 mph. We will continue to monitor this route to ensure that our operators are adhering to the speed limits.



31/32 LONG-TERM DETOUR RESOLVED



- Routes 31 and 32 will return to Leake Ave towards Children's Hospital
- Routing on Leake previously unsafe: intersection angle and vehicle speeds on Leake Ave
- Resolved with all-way stop sign at Leake and Carrollton
- No stops on Leake initially: additional work with City and Public Belt needed to improve pedestrian infrastructure
