8. Chief Planning and Capital Project Officer's Report

The monthly Chief Planning and Capital Project Officer's Report was presented. This report can be found in the PowerPoint Presentation for the Finance Report.

It was stated that the solicitation for the Algiers terminal building will go out this month or early next month and solicitation for the barges will happen during the month of June and this can affect the start date.

Tod Walton and Cynthia Gibson -Center for Transportation and the Environment (CTE) is the RTA's partner on the Zero Emission Fleet and gave a report on this project. This report can be found in the PowerPoint Presentation for the Finance Report.

The CEO stated that the training process was negotiated with the IBEW Union Contract, and the RTA has also started a training process with Delgado. This is CTE first time dealing with Louisiana and currently CTE has 140 current projects with different transit agencies. CTE stated that training needs to take place before the new buses arrive. The CEO further stated that CTE is also looking into the RTA's pilot program with the Zero Emission Fleet Infrastructure. CTE stated that there will be a Fleet Management System that would monitor each bus. CTE stated that the Body and chassis are the same of the regular vehicles and the life of each bus is 12 years, and the RTA can purchase a warranty with each bus.

Commissioner Colin thanked the presenters and stated that communication is very important with the implementation of this new bus system.
