Reinstall rail bonds

- 1. We will reinstall rail bonds per the drawing provided.
- 2. We will install 1- 2" sch 40 PVC per run to each rail bond. These conduits will be poured in roughly a 6"x6" concrete envelope up to the bond termination.
- 3. RTA will excavate all trenches and reinstall any backfilled material, including rock. Any Track leveling required after excavation is to be done by the RTA.
- 4. We will provide all conduit, wire, and rail bonds.
- 5. We require full track closure in the area. We anticipate this will take approximately 15 working days. this time does not include time spent by RTA excavating the area.
- 6. Our Price is based on a 6-day-10-hour-a-day schedule.
- 7. We have not included any protection of the steel bond plates.
