**TO AUTHORIZE A COOPERATIVE ENDEAVOR AGREEMENT (CEA) BETWEEN THE
REGIONAL TRANSIT AUTHORITY (RTA)
AND
ASHE' CULTURAL ARTS CENTER
FOR THE INSTALLATION OF A MURAL AT THE CANAL STREET FERRY TERMINAL
SITE**

WHEREAS, the Regional Transit Authority (RTA) is a political subdivision of the State of Louisiana;

WHEREAS, Ashe' Cultural Arts Center ("Ashe'") is a non-profit organization with its principal address located at 1712 Oretha Castle Haley Blvd., New Orleans, LA 70113;

WHEREAS, pursuant to Article 7, Section 14(C) of the Louisiana Constitution of 1974, and related statutes, the RTA is authorized to enter into cooperative endeavors with the State of Louisiana, its political subdivisions, corporations, public or private entities, and individuals to support public purposes such as economic development, public education, community development, housing rehabilitation, and other similar activities;

WHEREAS, the RTA is authorized to plan, design, lease, acquire, construct, improve, finance, and administer a transit system within the metropolitan area and to undertake activities that serve its governmental purpose;

WHEREAS, the RTA and Ashe' seek to collaborate to achieve a valuable public purpose by supporting the City's beautification efforts for Super Bowl LIX through the installation of a mural at the Arcade Wall located at the Canal Street Ferry Terminal Site;

WHEREAS, Ashe' will curate and manage the installation of the mural, and the RTA will allow the installation of the mural on the Arcade Wall at the Canal Street Ferry Terminal Site; and

WHEREAS, the RTA will provide funding in an amount not to exceed \$25,000 to Ashe' for the curation and management of the mural installation;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Regional Transit Authority (RTA) that the Chairman of the Board, or his designee, is authorized to enter into a CEA with ASHE' Cultural Arts Center.
