**AUTHORIZATION TO EXECUTE A THREE-YEAR CONTRACT WITH CLEVER DEVICES
FOR SOFTWARE SERVICES**

Introduced by Commissioner Walton,
seconded by Commissioner Guidry.

WHEREAS, RTA seeks to execute a contract to Clever Devices for a CleverInsights three-year a software and hardware systems upgrade for FY2025-2028; and

WHEREAS, The agency has undergone several maintenance contracts with Clever Devices and is in need of a contract renewal for FY2025 to ensure continued hardware warranty agreement and software maintenance. Clever Devices is used as the vehicle computer-aided dispatch and automatic vehicle location systems (CAD/AVL) which was installed on RTA vehicles, buses and streetcars. RTA received notification that in FY 2026, Ridecheck Plus, Clever Devices' Automated Passenger Counter feature contained within the maintenance agreement will sunset with CleverInSights coming onboard as the upgrade and replacement; and

WHEREAS, Clever Devices Ridecheck Plus provides data related to the agency's passenger counts and NTD and FTA reports. The CleverInSights three-year upgrade contract provides the agency with enhanced software user interface and file monitoring, manual checker module for Automated Passenger Counter (APC) at the ferries, support for hardware/software, technical support, and powerful report filtering, and tailored report customization for continued NTD and FTA reporting.; and

WHEREAS, The funding will be split between local and capital account codes for a total cost not exceeding TWO-HUNDRED AND EIGHTY-THREE THOUSAND TWO HUNDRED AND THIRTY-TWO DOLLARS AND THIRTEEN CENTS (\$283,232.13).
