5. Chief Executive Officer's Report

The CEO thanked staff for the support given to the City of New Orleans with the terrorist attacked that took place in the French Quarter on January 1, 2025. Brian Marshall was introduced to the Board as the new Chief of Operations. He came to New Orleans from the CATS Transit System in Baton Rouge.

7. New On-Time Performance (OTP) Calculation for Paratransit Presentation

The Chief Planning & Capital Projects Officer gave the New On-Time Performance (OTP) Calculation for Paratransit Presentation. This report can be found in the PowerPoint Presentation in the Operations Administration Committee Report.

It was reported that the operations have to wait a minimum of 5 minutes for a passenger to be within the window. There is an average of a 30 minute wait time for each passengers. It was reported that On-Time Performance was being calculated by the total number of trips - subtracting the late trips and divided by the total number of trips. Commissioner Daniels stated that he receives phone calls regarding Paratransit and he understands that the public can't always be wrong. The CEO responded by saying that the reservationist makes sure that each passenger was made aware of their scheduled pick-up times once their appointments are confirmed. The CEO reported that she was going to check and make sure that this information is in the Passengers Riders Guide.

It was also reported that the new software will improve the rider's experience and once the new software is installed staff will do a demonstration to show all the new capabilities that the new software offers. The CEO added that this new software was all a part of Change Management and there may be new rolls for dispatchers, routers and reservationist. Commissioner Sams commented that the RTA should partner with hospitals and the Council on Aging when this new software is implemented for software demonstrations.
