**RESOLUTION FOR CONTRACT AWARD OF EXCESS LIABILITY
AND AUTOMOBILE PHYSICAL DAMAGE INSURANCE COVERAGES
FOR POLICY YEAR AUGUST 1, 2021 TO JULY 31, 2022**

WHEREAS, the Board of Commissioners of the Regional Transit Authority (RTA) has considered the matter of contract award for excess liability and automobile physical damage insurance coverages for policy year August 1, 2021 to July 31, 2022 to several different firms; and

WHEREAS, the RTA insurance broker of record, Kennedy Financial Group of Louisiana, Inc., received and reviewed offers to provide the specific insurance coverage(s) required, and based upon that review determined that the selected insurer(s) would provide the coverage at a fair and reasonable price; and

WHEREAS, based upon these recommendations, the Board of Commissioners has selected Princeton E&S, Lloyds of London, Swiss Re, Markel, Endurance/Sompo, RSUI, and Roanoke Terrorism; and

WHEREAS, acquisition of new vehicles during the upcoming renewal year will require endorsement upon delivery and result in an additional Automobile Physical Damage premium payable within thirty (30) days of endorsement; and
