C. Justification of Change Order

Audubon Nature Institute (ANI) has requested additional hardscaping, landscaping and site work be performed by the Woodward APC during the Canal Street Ferry Terminal project. ANI has agreed to fund the design, construction, construction management, and future maintenance to the added scope of work that they have requested. The current approved budget for this work is \$1,000,000.00. Based on the latest information, the total cost for the ANI directed work is \$1,666,435.00. To date RTA has issued a change order for an allowance of \$1,000,000. This recommendation is to add to the allowance the additional amount of \$666,435.00. Royal has reviewed the budget increase request and finds it reasonable as an increase in allowance. Note that all billings against the allowance are reviewed independently for cost reasonableness and separate recommendations for approval are sent to ANI and the RTA for approval. Royal only recommends acceptance of this increase pending approval of the increase by ANI.
